
The Whatcom County Treasurer's office will soon foreclose on properties with severely delinquent property taxes and YOU appear to have an interest in property on their list. The purpose of this letter is not to alarm you. You or someone else may have already paid the taxes and terminated the foreclosure.

My actual purpose in writing is to simply let you know that I am a local investor who for the last twenty years has purchased interests in real estate, including contracts, liens, judgments, notes, deeds of trust, partial ownerships and just about any other interest in real estate that's headed toward foreclosure.
